addressing substance use disorders and the criminogenic needs of individuals, The Haven embodies a holistic approach to rehabilitation. It understands the intricate challenges individuals face, particularly those with justice involvement.

They often present health complex issues, mental health struggles,

need for community support, housing, and employment. The Haven is exceptionally equipped to cater to these requirements.

The admission process for the program starts with referrals from detox centers, correctional facilities, and legal defenders.

Before being admitted, individuals go through a general pre-screening process to check if they meet the company's exclusionary criteria. Individuals who maintain at least five days of sobriety and pose no safety risks would be selected to undergo a full bio-psychological assessment with one of Haven's specialized therapists before the services begin.

The journey through The Haven begins with a comprehensive three-tiered program residential, outpatient, and sober living. The residential program, extending up to six

months, prioritizes medical-assisted therapy and stabilization for an individual to get back on track after a relapse occurs. Its inhouse medication management helps them efficiently manage drug cravings through medicines like suboxone, sublocade, and methadone.

The subsequent outpatient phase, coupled with sober living, provides ongoing support through intensive outpatient, general outpatient, and aftercare programs. Individuals undergo various levels of care until they reach complete recovery. The Haven's sober living, a safe and affordable housing program offered by The Haven for recovering individuals, stands out for its unmatched recovery peer support in Utah. Its year-end analysis testing tracks the progress of individuals, enabling the company to chart future treatment plans accordingly.

Its long track record of successful treatments in Utah reflects its commitment to comprehensive care. In one instance, the company provided all-inclusive recovery assistance to a now prominent individual in the state. The person found it extremely difficult to maintain sobriety and had to go through several episodes of treatment. She was also pregnant during her third treatment. The Haven, with its tailored programs and dedicated support, empowered her to maintain her sobriety and thrive in her recovery. She now champions various overdose prevention campaigns and works for the company by sponsoring several members and actively participating in several events it hosts.
